## Secretary's Report

The November 7<sup>th</sup> meeting of the State Line Gem and Mineral Society was called to order by President Glenda at 2:18 PM. There were 14 members present. Glenda led the members with the pledge of allegiance, then Richard B. gave the invocation. Bill Schultz noted that last month's newsletter had an incorrect spelling in a guest's name. It should have been Rich Kussmaul instead of Cusbaugh. Linda Miller made a motion to accept the secretary's report as printed in the newsletter with the spelling correction. The motion was seconded by Charlene and passed with all in favor. Glenda stated that Linda W. checked into renting or buying semi trailers as discussed in last month's newsletter. Linda found that due to the supply chain problems, there were no roadworthy trailers for sale and the storage containers were not guaranteed to be leakproof and we would have to pay in cash. It did not sound like a good investment. There was discussion about finding a larger place for our meetings. Glenda did lots of research at several locations. She will contact the committee for a possibility of renting what was previously a church or school at 3973 Ogden Highway in Madison Township to see what the committee recommends. She also tentatively reserved a space for next month's meeting at the Lenawee Community Foundation at 1440 West Maumee St. in Adrian for December 5<sup>th</sup>. This is a free meeting place and the members present seemed to like that idea so that will be our next meeting location on December 5th. December is also our cookie exchange meeting so don't forget to bring cookies. There was some discussion about our annual Christmas dinner which we usually have at a restaurant. Glenda checked with the Family Kitchen where we previously had the dinner and found that they now require a minimum of 20 guests. There is also a new requirement that an organization is required to pay \$100.00 at the time the reservation is made and if there are less than 20 people who attend, the \$100.00 is forfeited. Steve said he would pay the \$100.00 and if there are less than 20 attendees it would be ok if he lost the money. Further discussion revealed that there was a restaurant in Lyons Ohio called Kay's which used to be the Lyons Den Restaurant. Linda M. will check into the possibility of having the club's Christmas dinner there and report at the December 5<sup>th</sup> meeting.

Bill Schultz reported that we were running low on geodes. We could use more \$10.00 and up sizes of the Indiana geodes and we needed 100 pounds each of the 3 ½ " and 2 ½" Mexican geodes. Sherm made a motion to order the 100 pounds each of the Mexican geodes. Jim seconded the motion which passed with all in favor.

Glenda stated that she was going to Arizona for two weeks in January 2022. Jim will be going there in December and Sherm, Ray and Henry will be going December 22<sup>nd</sup>. Let Glenda know if you want to go along and she requests that if members are there at the same time, they could get together for field trips.

Glenda mentioned that she wanted to reopen an issue which was previously tabled at a previous meeting. She feels that the president should have full access to the club's bank account. Currently, Doris who is the treasurer and her husband Richard who is secretary, and Sherm who is show chair, are all three on the club's bank account. One concern was that if Richard and Doris were in an accident there would be no one to access the account. However, Sherm would still be able to access the account. Kathy made a motion to amend the club's constitution/by-laws to specify that the club's bank account should have two unrelated board members on the account. One should be the treasurer and the other an unrelated board member. Bill Schultz seconded the motion which passed with two abstaining. Doris noted that the change would have to be submitted to maintain our 501 c 3 status. Steve said he would write the change and submit the proper paperwork.

Since there were no other individuals interested in running, it was decided that we did not need to mail out ballots.

Doris got an email from Artalicious asking if we preferred a one day show or a two day show for next year's Artalicious. A show of hands had the majority of members preferring a two day show.

Doris asked if anyone got any paperwork from Appleumpkin to attend next year. Sherm said he got the application. Glenda asked if he would be in charge of the applications for all the shows we do and he agreed.

Kathy made a motion to adjourn, seconded by Jim and passed with all in favor. There was lots of discussion about changing the club by-laws to eliminate the appearance of impropriety and prohibit married couples or otherwise related individuals from having access to the club's bank account. Steve carefully explained that it was no reflection on the current treasurer and secretary who are married to each other but it

could lead to improper use of club funds if related people were on the same bank

account. If such a change is passed by the club (not just 12 members who attend meetings in this time of Covid-19) that would mean that Richard B. would have to be removed from access to the clubs bank account. It would also mean that he could not write a check to the Post Office for stamps or pay any other club related expenses which require mobility since Doris has mobility issues. It is my opinion that if the club can not trust related/married people to be on the same bank account they should not be representing the club. Therefore, if the club by-laws are amended to prohibit related couples to be on the club's bank account, I will not be renewing my club membership.

# Treasurer's Report

Doris paid the rent and utilities and gave totals in checking and savings accounts. She also gave amounts earned from dues, geodes, grab bags and club sales. She paid for geodes ordered for sale at club events. Steve made a motion to accept the treasurer's report. Charlene seconded and the motion passed with all in favor. 2022 Dues for membership in the State Line Gem & Mineral Society are now due. The Dues are: Family Membership (Husband and Wife and Children under 18 years of age, all living under one roof)- \$15.00, Individual Adult Membership (All individuals over 18 years of age) - \$10.00. The above memberships are defined in Article II, Section 2 of the Constitution.

After the regular February meeting, all members whose dues remain unpaid shall receive a statement from the Treasurer. A Delinquent Member shall be that member whose dues are not paid by March 15th of the current year. Thereupon, voting privileges shall be revoked and publications discontinued. Full privileges shall be restored immediately upon payment of delinquent dues.

So, simply stated, what all the above information says is: Please pay your dues by February 06, 2022 so I don't have to remind you to pay them, and if you don't pay them by March 15, you will be delinquent and won't receive the newsletter or be allowed to vote until you do pay dues.
